BEING A BY-LAW OF THE MUNICIPAL CORPORATION OF HAMLET OF FORT MCPHERSON IN THE NORTHWEST TERRITORIES TO ADOPT A MUNICIPAL FLAG, SUBJECT TO THE APPROVAL OF THE MINISTER OF MUNICIPAL AND COMMUNITY AFFAIRS, PURSUANT OF THE PROVISIONS OF THE HAMLETS ACT, R.S.N.W.T., 1988, C.H-1, SECTION 128

AS the Hamlet of Fort McPherson desires to adopt and regulate the use of a crest and flag for the Municipal Corporation;

NOW, THEREFORE, THE COUNCIL OF THE HAMLET OF FORT MCPHERSON, at a duly assembled meeting, enacts as follows:

SHORT TITLE


- 1. This By-law may be cited as the "Community Crest and Flag By-law".


GENERAL PROVISIONS

- 2. The design depicted in Schedule 1, attached to and forming part of this By-law, is adopted as the Municipal Crest and Flag of the Hamlet of Fort McPherson.
- 3. No person other than the Hamlet of Fort McPherson shall:
 - a. use the Municipal crest and Flag under this By-law for any purpose, or
 - b. sell or otherwise dispose of any item for the profit containing the Municipal Crest and Flag, Without having first obtained from the Hamlet a permit to do so, in the form shown in Schedule 2, attached to and forming part of this By-law, on such terms and conditions as the Council may determine.
- 4. Every person who contravenes Section 3 & 4 of this By-law is guilty of an offense and is liable on summary conviction to a fine of not less than \$50.00 (fifty dollars) and not more than \$200.00 (two hundred dollars) or, in default of payment of a fine, to imprisonment for a period of not exceeding one (1) month.
