

FORGIVENESS OF DEBTS  
Bylaw # 189/04



BEING A BYLAW OF THE HAMLET OF FORT MCPHERSON IN THE NORTHWEST TERRITORIES TO FORGIVE CERTAIN DEBTS OWING TO THE HAMLET PURSUANT TO THE HAMLETS ACT S.N.W.T., 2003, c.22, s72.

Whereas debts have been identified as being uncollectable in the annual audits ending March 31, 2001 and March 31, 2002, and

Whereas, these debts remain in the Hamlet's accounting Program, and

Whereas, additional debts have been identified as uncollectable for the fiscal year ending March 31, 2003,

Now therefore, the Council for the Hamlet of Fort McPherson at a duly assembled meeting enacts as follows;

Short Title

1. This bylaw may be cited as the Forgiveness of Debts Bylaw #189/04.

Forgiveness

2. Subject to the approval of the Minister of Municipal and Community Affairs, all those debts owed to the Hamlet of Fort McPherson stated in Schedule "A" attached to and forming part of this bylaw are hereby forgiven for reasons determined as stated in Schedule "A".

CONFIRMATION

3. The Hamlet of Fort McPherson hereby confirms that those debts stated in Schedule "A" are not debts owed in respect of property taxes.

EFFECT

4. This bylaw comes into force and effect upon receiving third and final reading and at which point administration will ensure that these debts are removed from the Hamlet's Accounting Program.
