

HAMLET OF FORT MCPHERSON  
BY-LAW NO. 42

\*\*\*\*\*  
BEING A BY-LAW TO PROVIDE FOR THE NAMING OF ROADS WITHIN THE MUNICIPALITY  
\*\*\*\*\*

WHEREAS the Council is authorized to name roads within the Municipality in accordance with Section 71(d) of the Hamlets Act S.N.W.T., 1987 (1), C. 17.

NOW THEREFORE the Council of the Hamlet of Fort McPherson in a meeting duly assembled, enacts as follows:

1. Roads located in the Hamlet of Fort McPherson shall be named as follows:
  - a.) Tetlit Gwich'in Road - commencing at the Dempster Highway to the North end of the community.
  - b.) William Firth Drive - commencing at Tetlit Gwich'in Road at the North end of the community southwesterly along the riverbank and intersecting with Tetlit Gwich'in Road at Lot 5-3, Plan 366.
  - c.) Annie G. Robert Avenue - commencing at Lot 11, Block 4, Plan 137 at Tetlit Gwich'in Road easterly to intersect with Arthur Blake Street.
  - d.) Arthur Blake Street - commencing at Lot 7, Block 4, Plan 137 southerly to intersect with George Robert Avenue at Lot 1, Block 2, Plan 137.
  - e.) George Robert Avenue - commencing at Lot 11, Block 3, Plan 137 Tetlit Gwich'in Road easterly to intersect with Arthur Blake Street.
  - f.) Abraham Alexie Road - commencing at Tetlit Gwich'in Road, southwesterly across Lot 5-6, Plan 390, thence southeasterly across Block 29, Plan 1960 to intersect with Tetlit Gwich'in Road.
  - g.) John Tetlich Drive - commencing at Abraham Alexie Road, southerly along the riverbank to intersect with Tadit Francis Avenue at Lot 3-3, Plan 660.
  - h.) Chief Julius Avenue - commencing at John Tetlich Drive easterly to intersect with Charles Koe Road.
  - i.) Charles Koe Road - commencing at Chief Julius Avenue southerly to intersect with James Simon Road.

- j.) James Simon Road - commencing at Chief Julius Avenue, Lot 1, Block 13, Plan 874 southerly to intersect with the Dempster Highway.
- k.) Geeva-In Street - commencing at William George Vittrekwa Street southeasterly to intersect with James Simon Road.
- l.) William George Vittrekwa Street - commencing at Lot 1, Block 5, Plan 284 at Chief Julius Avenue southerly to intersect with Johnny Kay Avenue.
- m.) Tadi Francis Avenue - commencing at John Tetlich Drive Lot 3-3, Block 1, Plan 660 easterly to intersect with William George Vittrekwa Street.
- n.) Johnny Kay Avenue - commencing at William George Vittrekwa Street easterly to intersect with James Simon Road.
- o.) Andrew Kunnizzi Street - commencing at Johnny Kay Avenue southwesterly along Block 18, Plan 982 to intersect with Tetlit Gwich'in Road.
- p.) Edward Snowshoe Street - commencing at Andrew Kunnizzi Street northeasterly to intersect with James Simon Road.
- q.) Harriet Stewart Avenue - commencing at Edward Snowshoe Street Lot 1, Block 26, Plan 1985 southwesterly to end of road.
- r.) Charlie Wilson Street - commencing at Lot 1, Block 23, Plan 1640 Tetlit Gwich'in Road easterly to intersect with James Simon Road.
- s.) Peter Thompson Drive - commencing at Lot 16, Block 16, Plan 982 Tetlit Gwich'in Road northwesterly along the riverbank to the end of the road.
- t.) William Nerysoo Drive - commencing at Tetlit Gwich'in Road southerly along Block 25, Plan 1984 to intersect with Tetlit Gwich'in Road.
- u.) Alfred Tetlich Avenue - commencing at William Nerysoo Drive Lot 5, Block 25, Plan 1984 to end of cul-de-sac.
- v.) Mary Francis Street - commencing at William Nerysoo Drive Lot 14, Block 24, Plan 1984 to end of cul-de-sac.

- w.) Rebecca Modeste Street - commencing at William Nerysoo Drive unsurveyed Lot P21, Block 24, Plan 1984 to end of cul-de-sac.
- x.) Brian Francis Avenue - commencing at William Nerysoo Drive unsurveyed Lot P31, Block 25, Plan 1984 to end of cul-de-sac.
- y.) Charles Neyando Street - commencing at Tetlit Gwich'in Road at the southerly corner of Lot 1, Block 23, Plan 1640 easterly to end of cul-de-sac.

All as shown on Schedule "A" attached hereto and forming a part of this By-Law.




